# Factoring/ Owners Services



- •2011 Factoring Act requires ACHA to provide Statements of Service where we have previously provided services to Owners
- •ACHA are deemed to be a Factor of Common Parts of shared blocks
- Not a comprehensive factoring service
- Just under 4,000 Statements of Service have been issued
  Mid Argyll, Kintyre & Islay 1,409 issued
- •All Title Inspections being analysed



### Welfare Reform and the Bedroom Tax

- •Tenants affected by the Bedroom Tax 452. (136 in MAKI)
  - 57% have no arrears
  - -Value of Arrears £55,143
  - -11 Notice of Proceedings issued for Non Payment
- •Property Sizes affected:
  - -240 in 2 bedrooms
  - -139 in 3 bedrooms
  - -23 in 4 bedrooms



### **Welfare Reform and the Bedroom Tax**

### ACHA's Mitigation Strategy

- -Arrears Management Policy amended
- -Allocations Policy (HOME Argyll) amended
  - 31 tenants moved who are directly affected by the bedroom tax
- -"Tenant Incentive Scheme" introduced to facilitate transfers
- Big Lottery Award £296,994 to provide Financial &
   Welfare Rights Services to ACHA tenants
- Close partnership working with ABC
- -Preparations underway for Universal Credit
