

NOTICE OF MAKING OF AN ORDER TO EXEMPT LAND FROM ACCESS RIGHTS

LAND REFORM (SCOTLAND) ACT 2003

Section 11 – Power to Exempt Particular Land from Access Rights

Notice is hereby given under section 11(9) of the Land Reform (Scotland) Act 2003 (“the Act”) that on **Tuesday, 25 May 2021** Argyll and Bute Council made an Exemption Order (“the Order”) under section 11(1) of the Act.

The effect of the Order is to exempt land at Ben Cruachan (marked in red on the accompanying map) from the access rights, which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. ***This includes any parts of Core Paths or Public Rights of Way*** recorded within the area.

The purposes for which the Order is made:

TV production at Cruachan Dam that will involve 250 crew, vehicles, heavy plant and the construction of TV sets. There are three key areas where filming is focused and that restricted public access is required.

Monday, 07 June 2021 - 06.00hrs to 23.59hrs

Tuesday, 08 June 2021 - 06.00hrs to 23.59hrs

Wednesday, 09 June 2021 - 06.00hrs to 23.59hrs

Thursday, 10 June 2021 - 06.00hrs to 23.59hrs

Friday, 11 June 2021 - 06.00hrs to 23.59hrs

unless revoked earlier.

The Order is issued under the Land Reform (Scotland) Act 2003 and neither gives nor implies any other permission or consent that may be required.

This Notice should be displayed along with an accompanying map at each entrance point to the land in question for the entire duration of the exemption.

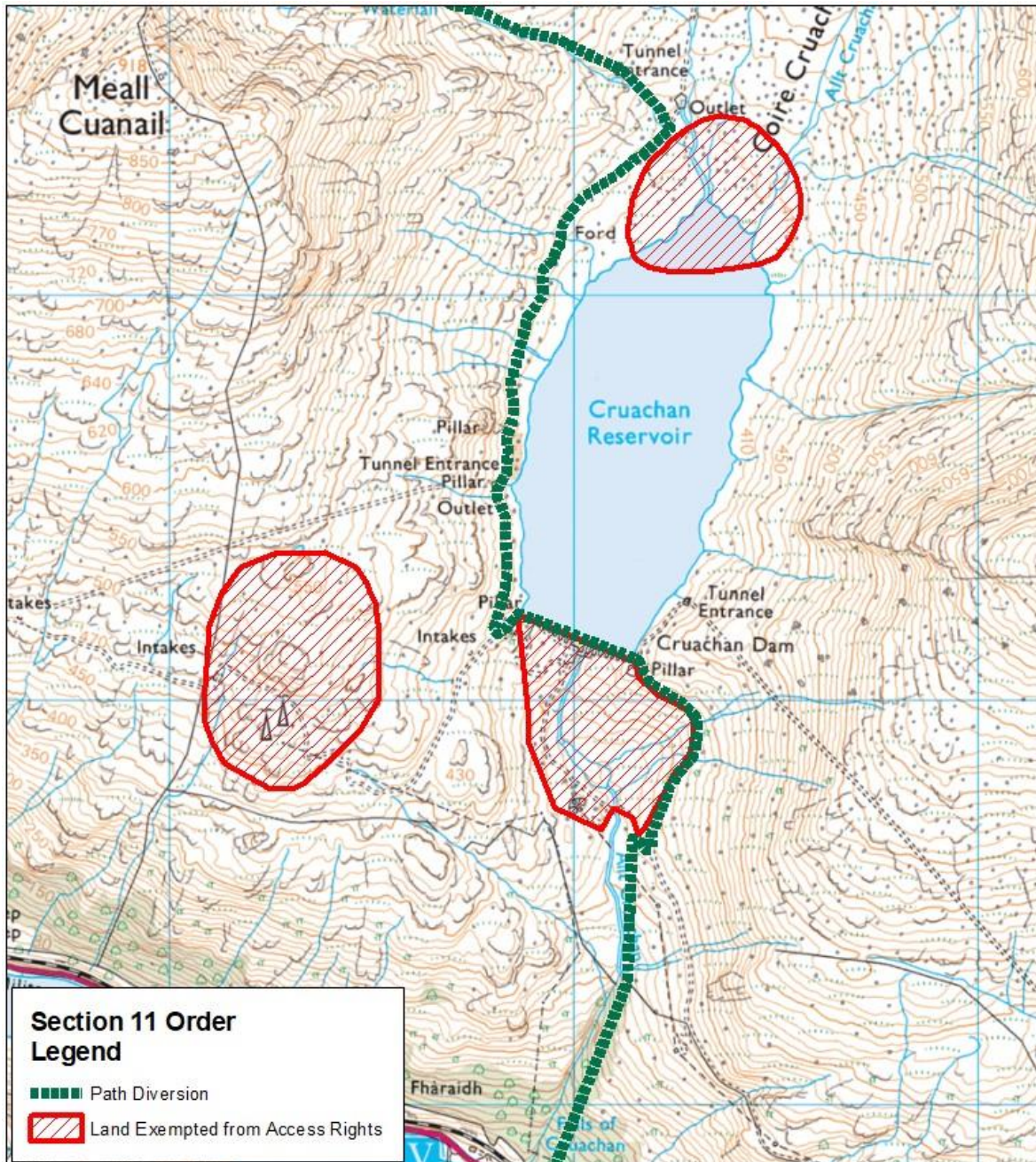

Location of land to be Exempted: ***Ben Cruachan***

Argyll and Bute Council **grants** an order to exempt the land identified above and shown delineated in red on the accompanying map for the purposes and time shown below from the access rights which would otherwise be exercisable in respect of that land by virtue of the Land Reform (Scotland) Act 2003. **This includes any parts of Core Paths or Public Rights of Way recorded within the area Marked in Red on the attached map.**
