The Council's Community Development Team continue to lead the delivery of support to Community Participation Bodies and engage with other Community Learning and Development partners as required.

Between August 2021 and November 2022, a member of Argyll and Bute Council staff was seconded to SCDC. Regular communication and updates were received throughout this time. The Council submitted a response to the Strengthening Participation Requests survey conducted by SCDC to share our experiences as a Public Service Authority.

There have been no challenges in accessing support.

3.2 Please provide details of action taken to promote the use of Participation Requests or support Community Participation Bodies in making a Participation Request.

For example this could include: Support before making a request, such as to determine whether a participation request is the most appropriate route; Support to make the request such as assist groups to complete forms, or identify appropriate outcomes; and/or Support to take part effectively in outcome improvement processes (whether or not they resulted from a formal participation request).

The Council offer support to those interested in submitting a request through Community Development and provide guidance to Community Participation Bodies during the process.

The process and the resources to support communities have been promoted through Argyll and Bute Council's Community Development Bulletin which is circulated to over 500 community contacts. This has included promotion of the resource pack created by the Scottish Community Development Centre.

In March 2023 a presentation was delivered to Elected Members to promote understanding of the Participation Request process and to encourage Members to share information and resources within their communities.

Participation Requests were included as part of community engagement training for Community Councils delivered between February and March 2023. This included both online and in person sessions with 52 Community Council representatives in attendance.

The Council has promoted SCDC's resource pack which includes information in accessible formats. Updates have also been made to the Participation Request webpages to make it more accessible, this includes having a paper form available for download or to be sent by post to those who have barriers to digital participation.

Information about the Participation Request process and the resources available has been further shared through the Community Development Bulletin. The bulletin distribution list includes community organisations who support those with protected characteristics.

The ongoing review of the Argyll and Bute Outcomes Improvement Plan will continue to offer opportunities for communities to participate in shaping local priorities. The continued development of the plan will support the delivery of existing outcome improvement processes as well as wider community empowerment.

The initial consultation and engagement for the Argyll and Bute Outcomes Improvement Plan by the Community Planning Partnership has been considered best practice. This provided comprehensive support to those with digital barriers and protected characteristics to participate.
