Fuel Poverty in Rural Scotland

This report evidences the drivers, impacts, and extent of fuel poverty in rural Scotland. It outlines a series of interlinking factors which combine and compound each other to produce a 'perfect storm' for severe fuel poverty in rural Scotland.

In addition to the four recognised drivers of fuel poverty, the research identifies a set of rural specific drivers which contribute to significantly higher fuel poverty and extreme fuel poverty levels in rural areas, when compared to the rest of Scotland. The rural specific drivers of fuel poverty include factors such as a cold and wet climate, a lack of affordable housing, and limited access to support services.

To explain why fuel poverty is so pervasive in rural Scotland, the report also outlines the structural barriers to fuel poverty alleviation, including where current policy designed to limit or alleviate fuel poverty fails to recognise the realities of fuel poverty in rural Scotland. Argyll and Bute Outcomes Improvement Plan (2024-34): Development Process Update



The Community Planning team has been hard at work continuing to gather the information needed to develop the Argyll and Bute Outcomes Improvement Plan (ABOIP), which will guide the work of the Community Planning Partnership (CPP) for the next ten years.

The Community Empowerment (Scotland) Act 2015 requires each CPP to produce a Local Outcomes Improvement Plan. Statutory guidance tells us that this Plan should:

- Demonstrate a clear, evidence-based and robust understanding of local needs, circumstances and aspirations of its local communities.
- Aim to tackle causes of inequalities rather than consequences.
- Use preventative approaches.
- Focus on a small number of local priorities where the CPP will add most value as a partnership

 in particular by improving outcomes for its most vulnerable and disadvantaged communities
 and moderating future demand for crisis services.

As part of the ABOIP development process, we conducted the *Improving Lives in Argyll and Bute Survey.* Almost 2,000 Argyll and Bute residents responded. We learned that, from a community perspective, Transport Infrastructure, Housing and Community Wellbeing were the three themes most in need of improvement.

Our next step was to seek input from the CPP Management Committee. Community planning partners are experts in providing services to the communities of Argyll and Bute. As such, they have vital knowledge and experience arising from the ongoing work of their organisations and

observations of the communities that they work with. We wanted to understand partners' views on where partnership working is most needed. We also wanted to understand where partners were seeing the greatest inequalities relating to the community's top three priority themes of Transport Infrastructure, Housing and Community Wellbeing.

To explore these issues, CPP Management Committee members came together at a Development Day, held in Arrochar. This was the first time since the outbreak of the COVID-19 pandemic that many of the committee members had met in person. Many committee members had joined after that time and so had never met face-to-face before. We were reminded how valuable it was to be in a room together and have the opportunity to get to know each other in a way that isn't always possible during a virtual, online meeting. The partners were able to have interesting and useful discussions about each of the community's top three priority themes.

These discussions, along with the findings of a survey for all partners, including those who were unable to join the Development Day, will inform the next stage of the process of developing the Outcomes Improvement Plan. This will involve cross-checking input from the community and partners with available data sources to further refine focus on the communities and places experiencing the greatest inequalities. A series of focus groups will be held later in the year to explore "what does good look like?" We will combine all of these findings to develop the Outcomes that the CPP will aim to achieve through partnership working from 2024-34.

The cost of debt for low-income households in the cost of living crisis

The human cost of the cost of living crisis so far is as clear as it is disturbing. By May 2023, nearly two thirds of the poorest 40% of low-income families, 7.3 million households in total, were being forced to make sacrifices on one or more essential – such as

prescription medicine, adequate clothing, or a hot shower. Within this number, 5.7 million were routinely reducing or skipping meals. The social scarring will likely stay with us for decades to come. Read the report here

New grant funding to decarbonise public sector buildings

A new funding scheme has been launched offering up to £20 million in grants to support local authorities, universities and arm's-length external organisations decarbonise their buildings. Applications will open via the <u>Salix Finance</u> website later this summer.

Opportunity to shape Just Transition Plans

You are invited to support a programme of engagement on delivering a just transition to net zero for Scotland, which the Improvement Service is carrying out on behalf of Scotlish Government.

In <u>response</u> to the initial report of the <u>Just Transition Commission</u>, the Scottish Government committed to deliver a series of Just Transition Plans (JTPs) focussed on sectors that the Commission identified as key to delivering Scottish Minister's ambitious net zero targets:

Built Environment and Construction:

- Land Use and Agriculture; and
- Transport.

In its National Planning Framework, Scottish Government outlined that co-design and co-delivery must underpin the just transition planning process. It is therefore committed to delivering meaningful engagement throughout the development of the draft JTPs.

To begin the development of these JTPs, the Scottish Government has published a series of discussion papers on each of the sectors to start to outline what they think might be the key challenges and opportunities that the transition to net zero will bring in each area. 

JRF Report: Deepening Poverty in Scotland - No-one left Behind?



This briefing studies the shocking increase in very deep poverty in Scotland.

In the last 20 years or so, while overall poverty levels (and particularly those for children and pensioners) have fallen, the proportion, and number, of people in very deep poverty has risen dramatically.

This technical briefing sets out to expose and explain this pattern – using a long series of poverty statistics from 1994 up to the start of the Covid-19 pandemic.



Shut Out Scammers Campaign 2023

As more Scottish consumers struggle with price increases and rising energy bills, Trading Standards Scotland and Police Scotland have launched a nationwide Shut out Scammers campaign.

The campaign aims to empower consumers rather than make them fearful and to encourage the reporting of scams.

Rogue traders and companies may attempt to exploit the cost of living crisis and scam consumers by providing misleading information about products and services and posting misleading adverts and reviews online.



Dishonest companies target those who want to save money on their energy bills, saying that funding or grants are available for their products, yet asking consumers to pay for the products up front or take out a loan. Consumers are told that they will receive their money back over time but rarely do.

New Cost of Living Hub for Community Councils

Ginning Council

A new <u>Cost of Living Hub</u> has been created to support community councils and their communities with the cost of living crisis. It includes resources from Scottish Government and other agencies as well as a collection of resources organised by local authority area. The hub will be added to on a regular basis and will also include information on webinars and other relevant events as well as case studies

highlighting the inspirational work of Scotland's urban, rural and islands community councils.

School Uniform Initiative



Argyll and Bute Council has been working with its schools and third sector partners to roll out a new, innovative scheme that will see school uniforms that children have outgrown, either reused or recycled - saving peoples' purse and the planet. Partners include schools, parent councils, volunteers, Kintyre Recycling Limited, Oban Baptist Church, Helensburgh Parish Church, and Dunoon Community Hub.




The council and partners are working to support people and businesses affected by the cost of living crisis in Argyll and Bute.

Please find here a summary of that work, the sources of help and advice that are available and please feel free to share this with third parties and other organisations.

DETAILS:

Argyll and Bute's island, rural and mainland geography brings additional cost to our citizens' day to day lives (as highlighted in a report to Council on 29th September). For fuel costs alone this means that 70% of our households are at risk of fuel poverty or extreme fuel poverty; impact on additional key areas of living are outlined in the graphic below and at the end of this information note.



Working with partners to support people and businesses:

The council's FIAG group (Financial Inclusion and Advice Group) brings together council services and support agencies. To make it as easy as possible for people to get support when they need it the council provides a 'one-stop-shop' of information on our website to provide key information and also help and information on money saving initiatives such as cheaper deals for internet connection and the availability of warm spaces provide by other organisations: www.argyll-bute.gov.uk/advice-services

We summarise below some of the help available:

Fuel

FIAG brings together different sources of support specifically with fuel costs on our website: <u>Heat your home - managing rising costs (argyll-bute.gov.uk).</u> This includes information about warm spaces – (link may be slow to load) https://www.argylltsi.org/warmspaces.html

Money

Bute Advice Centre and ALlenergy produced a <u>booklet highlighting financial support services</u> <u>available across Argyll and Bute</u>. This includes for example maximising income, foodbanks, energy and budgeting advice. It has been widely circulated to Elected members, across the NHS, Schools, support agencies and is available on the <u>Bute Advice Centre website</u>. *Argyll and Bute Scotland Loves Local Gift Cards* The Council is rolling out an initiative to provide £120 gift cards to around 6,650 Council Tax Reduction recipients. This will support households on low incomes and the local businesses registered for the card. *The Council is looking at a proposal to develop Welfare Rights & Health Partnerships in Argyll & Bute*. The pilot is looking at 5 practices within Mid-Argyll, Kintyre & Islay where the Council would embed Local Authority welfare advice specialists within the practice's healthcare setting for an average of one day per week per practice.

Data mining to identify benefits eligibility and maximise household income The Council's Data Advisory Group is working on matching data from relevant council systems to identify unmet benefit eligibility so we can support eligible households to maximize their income.

Food

<u>Flexible Food Fund</u>: The Fund provides a one-off cash payment to families on low incomes to help with food and fuel. The size of the payment is based on their household composition. Claimants are offered a second cash payment if they have engaged with support agencies, the Bute Advice Centre and ALIEnergy, in financial management. The project achieved national acclaim in October 2021 for Excellence in Innovation from the Institute of Revenue Rating and Valuation. Over 96% of people receiving the first grant payment engage, get the support they need and get a second payment; applicants, through different routes, have received a total of £2 million they could otherwise have missed out on.

Food banks: there is a list of food banks on the council's website

Clothing

Preloved School Clothing Project. The Council and its schools are working with community groups to give every child in Argyll and Bute access to a school uniform, by developing a uniform re-use scheme. There is a reused school uniform hub in Helensburgh, one nearing completion in Campbeltown, and work in in planning for schemes for Dunoon, Rothesay, Oban and Lochgilphead, Tarbert, Islay and Mull.

Support

Additional funding for advice agencies. The Council has provided £40,000 in funding to ALIenergy, Bute Advice Centre and the Argyll and Bute Citizens Advice Bureau to help them meet increasing demands from the public between 1 April 2022 to 31 March 2023. Anti-poverty training. The Poverty Alliance has delivered training across the Council and Community Planning Partners on anti-poverty actions and this will be extended to elected members on 30 November.

Promoting information

The Council's Communications Team is already using social media and also statements provided to local press in the area to reach groups and individuals who perhaps don't use social media to make people who need it, aware of support available, using for example digital and traditional media channels, and word of mouth, inviting the help of Councillors, council employees, partner agencies and the public in passing information on, via whatever channels they have, to people who need it.

GRANTnet is a straightforward free to use service which can help you identify suitable funding for your activity or project across a wide range of funding sources.

What is GRANTnet?

- Up-to-date information on over 7,000 grants and other incentives,
- Rapid identification of funding sources specific to need,
- Data sourced from EC and UK Government sources, including Government departments, local authorities, charitable trusts and corporate sponsors.

How to access GRANTnet

You can access the Grantnet home page here.

When using the system for the first time, go to the 'Log in / Register' page here and enter your details including your e-mail address (this will become the username), name, organisation, postal address and telephone number. Clicking on the 'Register' button will generate an e-mail providing a password.

Using GRANTnet - When you log into the system you must answer some questions about your organisation and the project which you wish to undertake. GRANTnet will then provide an overview of all the funds available.
