- 1. THIS IS A FORMAL NOTICE** which is served by Argyll and Bute Council, under Section 145 of the Town and Country Planning (Scotland) Act 1997, because it is considered that a condition imposed on the grant of planning permission, relating to the land described below, has not been complied with. It is considered that you should be required to comply or secure compliance with the condition specified in this notice.

2. THE LAND AFFECTED BY THE NOTICE

The site to which this notice relates (shown edged in red on the attached plan) forms an area of land known as **Laltagan, Bruichladdich, Isle of Islay PA49 7UT**

3. THE RELEVANT PLANNING PERMISSION

The relevant planning permission to which this notice relates is the permission granted by Argyll and Bute Council (Reference Number: 06/02350/DET) on the 8th February 2007 for the Erection of two dwellinghouses

4. BREACH OF CONDITION

The following condition(s) has/have not been complied with:

6. Prior to the development commencing a full appraisal to the satisfaction of the Council as Planning Authority of the wholesomeness and sufficiency of the private water supply to serve the development shall be carried out by a qualified hydrologist to the satisfaction of the Council's Chief Protection Services Officer. Such appraisal shall include a risk assessment having regard to the requirements of the Schedule 4 of the Private Water Supplies (Scotland) Regulations 2006 and shall on the basis of such risk assessment specify the means by which a wholesome and sufficient water supply shall be provided and thereafter maintained to the development. Such appraisal shall also demonstrate that the wholesomeness and sufficiency of any other supply in the vicinity of the development, or any to her person utilising the same source or supply, shall not be compromised by the proposed development. Furthermore the development itself shall not be brought into use or occupied until the required supply has been installed in accordance with the agreed specification and provided to the satisfaction of the Planning Authority.

Reason: In the interests of public health and in order to ensure that an adequate private water supplying terms of both wholesomeness and sufficiency can be provided to meet the requirements of the proposed development and without compromising the interests of other users of the same or nearby private water supplies.

5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

- 1.) Implement the private water supply to the satisfaction of Environmental Health to provide a wholesome and sufficient water supply to serve the dwellinghouse


6. TIME FOR COMPLIANCE

Time for compliance: 35 days from the date the notice takes effect.

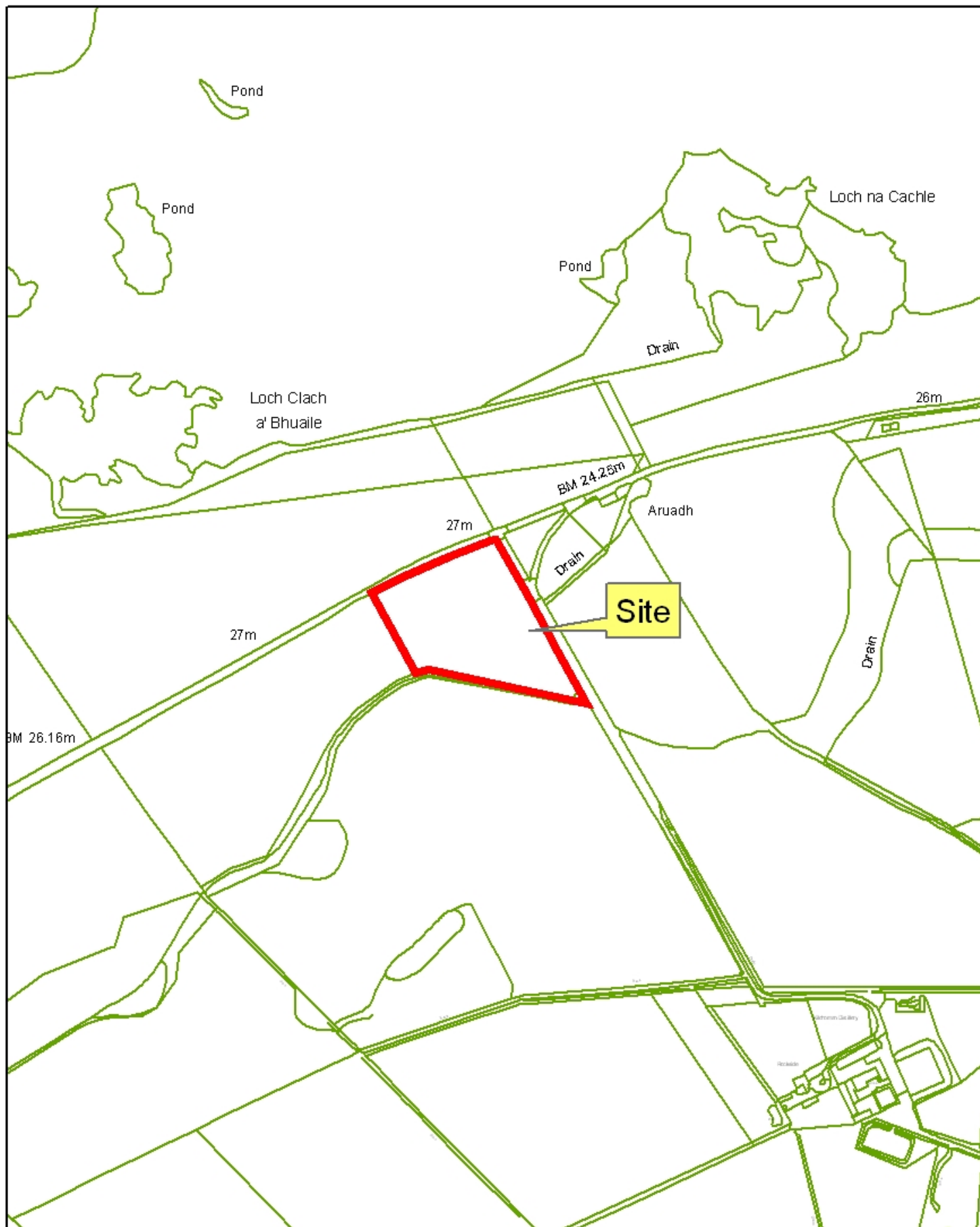

If you wish to contest the validity of the notice, you may only do so by an application to the Court of Session for judicial review. A lawyer will advise you on what procedure this process involves.

PENALTIES FOR NON-COMPLIANCE WITH A BREACH OF CONDITION NOTICE

Failure to comply with this notice may result in the Planning Authority instigating further planning enforcement proceedings such as an Enforcement Notice or a Fixed Penalty Notice.

The 2006 Act amended the 1997 Act to introduce a new planning enforcement power enabling planning authorities to issue a fixed penalty notice (FPN) as an alternative to prosecution where a person fails to comply a breach of condition notice to correct a breach of planning control. Failure to comply with this notice may result a fixed penalty notice being issued, with a fine of £300 in respect of a breach of condition notice. Please note that while payment of this fine prevents future prosecution this does not remove your responsibility to comply with the terms of this notice and may, as a result, instigate the undertaking of further planning enforcement proceedings.
