THIS IS A FORMAL NOTICE which is served by Argyll and Bute Council, under Section 145 of the Town and Country Planning (Scotland) Act 1997, because it is considered that a condition imposed on the grant of planning permission, relating to the land described below, has not been complied with. It is considered that you should be required to comply or secure compliance with the condition specified in this notice.

2. THE LAND AFFECTED BY THE NOTICE

The site to which this notice relates (shown edged in red on the attached plan) forms an area of land known as **TAIGH A'MHONADH**, **CAMPBELTOWN**

3. THE RELEVANT PLANNING PERMISSION

The relevant planning permission to which this notice relates is the permission granted by Argyll and Bute Council (Reference Number: 07/00387/DET) on the 26th April 2007 for the erection of dwellinghouse and installation of septic tank

4. BREACH OF CONDITION

The following condition has not been complied with:

2. The access onto the public highway shall be formed in accordance with the Council's Highway Drawing Nos. TM 197and G300 with the bellmouth area surfaced in dense bitumen macadam for a distance of 5m back from the existing carriageway edge and dropped kerbs formed. Visibility splays of 2.0m by 160.0m shall be formed in each direction from the centreline of the access onto the public highway. Prior to work starting on site the access shall be formed as per the duly approved details and the visibility splays cleared of all obstructions over 1.05m in height above the level of the adjoining carriageway and thereafter shall be maintained clear of all obstructions over 1.05m in height to the satisfaction of the Planning Authority.

Reason: In the interests of road safety.

4. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Form the access as per the roads requirements in condition no.2 above.

5. TIME FOR COMPLIANCE

Time for compliance: 28 days from the date the notice takes effect.


