4. BREACH OF CONDITION

The following condition has not been complied with:

3. Within one month of the new access being brought into use, the existing field access shown on the approved plans shall be permanently closed off to vehicles, either by soiling over the verge and access, or by removal of the stone culvert.

Reason: In the interests of road safety.

5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply/secure compliance with the stated condition(s) by taking the following steps:

Close off the exiting access permanently to vehicles, either by soiling over the verge and access, or by removal of the stone culvert.

Time for compliance: 35 days from the date the notice takes effect.


