

How good is your place? Area wide engagement results using the Place Standard Tool

Between May and October 2019, the Community Planning Partnership (CPP) used <u>the Place</u>

<u>Standard tool</u> to engage residents in Argyll and Bute on how they feel about the place(s) that they live and work in Argyll and Bute.

We are very grateful to all the responses that we received. We hope you find the information easy to understand and of interest to you and your community.

We are pleased to see that the thematic areas of Natural Space, Feeling Safe, Identity and Sense of Belonging and Social Contact came out with the highest scores, needing the least improvement, when considering Argyll and Bute as a whole.

The engagement has been undertaken at a place-based level and respondents provided their postcode, groupings of postcodes have created the settlement/community level detail.

The results are available for community groups and partner agencies to use, for example, to assist with service planning or for community-led action plans.

Please note: The information is the views of individuals who responded to the engagement. We trust that the information provided will be viewed within the context of which it is provided. We are grateful to all those who have taken part in the consultation and believe in sharing information for openness and transparency.

We appreciate that the documents can be lengthy due to the amount of information and we hope that the format is user-friendly.

We are currently mapping out what activity is already happening, what is planned within the next 3-4 years and where the gaps are. This information will be considered by both the CPP Management Committee and the Area Community Planning Groups to shape the actions.

Hilly area so cycling is tricky!

I live on A814 to Arrochar, there is no footpath/cycle track and the road can get very busy during the summer.

No pavements or safe roads to walk along

Not enough bus stops, roads are poor quality. Not enough cycle or walking routes.

There are no safe walking or cycling routes in or around Portincaple.

There are no safe walking or cycling routes in Portincaple. There are no pavements or lighting and the only road is single track and has a 60 mph limit. There are no walking or cycling links to Garelochhead or beyond. It is certainly not safe to walk on the road in winter. The road is increasingly busy with additional houses being built in the hamlet yet no improvement to the road has been made.

There are steep hills to negotiate both in and out of the community, and when arriving at the main road it is narrow with no escape routes to avoid traffic even walking is treacherous.

The only public transport available is dial a bus which lacks convenience and requires a lot of planning ahead of any trip.

There is a bus service on demand but for normally fit adults we require to walk two miles to Garelochhead. There was a very useful train station close to the community but this was closed in 1964. A request stop would make access very much better

There is no public transport from or to Portincaple. The nearest public transport is in Garelochhead to which there is no safe walking route. There is a my bus facility but this requires a great deal of forward planning and is very limited in its availability such that it is of no use.

No parking arrangements

No problems currently with traffic or parking. Feuins Road is very narrow but since we have little traffic it rarely causes any problems.

No speed restriction in the village.

Not much public parking available. People have to use the Green Kettle car park.

Visitors to Portincaple park on any available verges which restricts road width.

The main road although narrow still has to cope with residents having to park off their driveway in inclement weather when access and egress is impossible.

Traffic is increasing exponentially in the hamlet. Each new build brings two or three additional cars, multiple delivery vans, lorries and cars. Visitors - mostly fisher-people and tourists (who enter and exit without stopping as they meet a dead end and no access to the shore) park in the road narrowing the carriage way and making the road even more dangerous for pedestrians. The one - essentially single track road - is increasingly busy and increasingly noisy. We have lived here for more than 20 years and over that time there has been a notable increase in traffic. I feel unable to walk the road for pleasure at all and must use my car if I wish to get a pint of milk.

The area does have a great deal of views of the surrounding area as housing does encroach although further development may well obscure these views. This has already happened with one house on the access road which has been given planning permission although fortunately not yet built.

You cannot pass through Portincaple. The hamlet is very pretty. Bad weather combined with the steep slope when exiting and entering the hamlet makes it very dangerous if more than one car is trying to exit the village at the same time.

Generally feel safe except when I want to walk anywhere from the house as there is no footpath

I feel safe with my community but too many visitors in the summer abuse the locals and spoil natural amenity of the settlement leaving all kinds of litter including human waste.

It is safe at present because of the isolated nature of the settlement. Proposed developments for the hamlet would seriously threaten this feeling.

Shore based anglers from outside can cause disturbance pollution with rubbish and local theft mainly in summer months with long daylight hours.

Strangers speeding along road with no respect for locals or kids playing - holiday lets

There aren't enough streetlights but apart from that I feel safe.

Local residents' association recently set up and seems to be working effectively for the benefit of the community. Limited interaction with the Community Council.

No local buildings to maintain, library in Garelochhead was left years in disrepair before being demolished. School windows still boarded up months after being broken

Older buildings are badly maintained - private landlords/factors don't look after them - trees growing out of gutters etc., rotten neglected buildings/windows/down pipes & gutters. Wheelie bins left in streets permanently, chewing gum/cigarette ends/litter on pavements.

Recycle areas and rubbish collections could be improved

The verges are not maintained and add to safety issues on the one single track road. The dangerous bend sign is faded and hidden by vegetation. The council seems not to care about Portincaple. We only have a large glass bin at a central location. This is not usable for those unable to carry heavy glass waste. I imagine those with mobility problems would be unable to live in Portincaple.

There is little or no verge maintenance and recycling of glass is central. It is not possible to carry heavy glass to the central recycling facility in Portincaple and individual uplifts should be provided. Bin uplifts are unreliable. We are treated like second class citizens by the local authority.

Council not interested in rural communities

No one pays any attention to objections made about planning applications in the hamlet so why bother.

Recently a residents association has started up again but this is because of a serious threat to all of the things that are being asked about in this survey. I feel that the planning department never listen to residents when they express concerns about new development proposals and that it is totally unclear what their plan is for the hamlet. We have a shaded pink area where settlement is deemed to be possible but no guidance as to what this might mean and at what point the infrastructure will have to be improved. I strongly feel that any concerns are dismissed out of hand and that local people's opinions are simply unwanted and unwelcome.

Within Portincaple we have an active residents' association however more widely I do not feel I have a voice in decision-making.

What are the main issues and priorities for change that you have identified?

Finish off Hermitage Park properly. Clear the streets of rubbish/bins etc. support and promote small businesses

Footpath along A814

For me - as I enter old age - is to have public transport available to link me easily and regularly to Garelochhead and Helensburgh - a bus stop at the top of the road and no increase traffic on the road in and out of the hamlet might mean that I will be able to live in my home for longer. However, I relish the lack of immediate amenities in the hamlet itself and the sense of isolation that living here provides so I do not want this unique aspect of Portincaple to be lost.

Improvements on the main A814 to both pedestrians and cyclists for access to Garelochhead. Careful vetting of planning consent to retain character and views of the surrounding area.

Local development plan consultation

public transport safe access to Garelochhead for pedestrians/cycle

Regular public transport services to and from the village. Kerbside recycling for glass. Better and more regular verge maintenance to keep Feuins Road safe and clear.

Transport links Improvements in roads More attention to rural communities not everyone lived in Helensburgh

What actions could be taken to deal with these?

A separate cycleway/footpath within sight of the A814 directly to Garelochhead. More diligent scrutiny by planners.

Better communication on what is being done in terms of community engagement and consultation

Environmental Wardens could enforce - remove bins from streets, fine littering. Impel landlords to improve neglected buildings. More promotion of small businesses - encourage people to visit more and spend more

Local bus service protected pedestrian routes

More communication with local rural communities for planning developments

Provide a regular and frequent bus service to and from the hamlet/ Reopen Whistlefield railway station. Provide a kerbside glass collection for everyone who can currently get kerbside bin (food/general and paper) collections. Local authority take responsibility to maintain verges on Feuins Road to ensure road safety.

Regular bus service, a halt on new developments which increase traffic on the road making it increasingly impossible to walk the road safely, making the road a twenty is plenty area, verge maintenance and sign replacement, possibly other traffic calming measures.
