# **Crude Oil Leak at Finnart**



Argyll and Bute Council is coordinating a multi-agency response following a small quantity of light crude oil surfacing from an underground pipeline in the area local to Finnart Ocean Terminal, Argyll and Bute.

Petroineos, who own and operate the site have deployed specialists in spill containment and recovery to the area in Glen Fruin where they remain on site. The leak is located in a small area and all residents living in close proximity of

the site are aware. SEPA is supporting the response and is on site to ensure all necessary clean up measures are taken.

Investigations are ongoing but there is currently a very low risk to the wider public. A cordon is in place to prevent access to the site. NHS Highland's Health Protection Team (HPT) is working closely with the council's Environmental Health Team to assess any implications for a small number of private water drinking supplies. The Public Health Protection Team will continue to work with the multi-agency group to assess any implications for health as investigations continue. Partners include, Police Scotland, SEPA, NHS Highland Public Health, Scottish Water and Loch Lomond and The Trossachs National Park Authority.

## <u>Dunoon Shaping Places for Wellbeing: Impact of Local Policing Work</u>

The Shaping Places for Wellbeing Programme is a delivery partnership between the Improvement Service and Public Health Scotland (PHS), funded and supported by The Health Foundation and Scottish Government with support from COSLA. It is a three year programme, running until March 2024.

The programme supports local authorities, health boards, and their partners to consider 'place' in a comprehensive and consistent way, whilst delivering on interventions and a range of national ambitions and key government policy aspirations including 20-minute neighbourhoods, the review of Scotland's Town Centre Action Plan and Scotland's Public Health Priorities. The positive engagement between the Shaping Places for Wellbeing Programme and Police Scotland has opened up space for discussion about the contribution of local policing work to a place and the role of partnership working by the police in the prevention of ill health.

In the Dunoon Project Town the activities have included:

- Participation in the Dunoon Shaping Places for Wellbeing Steering Group
- Sharing of data insights
- Doing a Place and Wellbeing Assessment of the Local Policing Plan

The work was seen as a test for considering how to bring local insight and a place approach into the planning work of Police Scotland. The learning is now being shared across project towns and through the partnership at a national level.

## **Argyll and Bute Leads the Way in Employment and Training**

New figures just released show that 95.6% of 16-19 year olds in Argyll and Bute are currently in education, training or employment, an increase of 1.7% on 2022 and 1.3% above the national figure of 94.3%.

The Annual Participation Measure (APM) gauges the Scottish Government's progress in meeting its commitment to offer a place in learning or training to every 16-19 year old in Scotland.



In 2022-23, the number of young people in employment in Argyll and Bute increased to 29.9% from 24.2% in 2021-22. Across Scotland, 21.4% of young people are in employment, which is a rise of 3.9% nationally from 2021-22.

## **Artificial Intelligence for Public Good**

The Joseph Rowntree Foundation (JRF) launches a new Artificial Intelligence (AI) project. Bringing together a wide range of perspectives, from tech experts and public sector actors to not-for-profit organisations and grassroots groups, the project will examine ideas on the development and implementation of AI that creates public good.

'Public good', refers to impacts or outcomes from AI that benefit the general public and are fairly distributed across society. The aim with the project is to broaden and deepen existing AI debates cutting through the hype of current mainstream narratives and legitimising and involving the voices of non-tech experts.

### First Time Volunteers in 2024

Some 14% of UK adults plan to volunteer for the **first time** in 2024, according to a survey by The National Lottery Community Fund.

Half of respondents said they intended to take part in formal or informal local volunteering activities this year. Seven in ten (72%) say it's important to them to feel part of their local community, and six in ten (59%) say community spirit is strong where they live.

The benefits of a strong community were seen to be: feeling safer (59%), having more awareness of what is happening (58%) and a greater sense of belonging (55%) in their local area with 45% saying that having an opportunity to meet people is a benefit of being part of their community.

# Still Time! Apply Now for UHI Courses Starting in January

Apply now and start learning something new in January 2024. UHI short courses can help job seekers to improve their CVs and provide subject tasters to help decide whether to progress further. Full time courses are free for Scottish residents and those on low incomes will receive a bursary for living costs. Part time courses can fit around work, or job-seeking so that benefits stay unaffected.

## Building standards enforcement and sanctions: consultation

In Scotland, a Ministerial Working Group was set up following the tragic fire at Grenfell Tower in 2017, to review building and fire safety regulatory frameworks. The Group identified the need for improving aspects of the building standards system.

The Scottish Government is now seeking views on proposals that aim to strengthen existing enforcement powers used by local authorities (LAs), and increase existing penalties for offences to act as a deterrent to persons who commit offences under the Building (Scotland) Act 2003.

The Bill aims to further improve decision making and the implementation of the National Performance Framework to ensure that all policy and delivery is focused on increasing the wellbeing of people living in Scotland, both now and in the future. These actions will see the sector make a vital contribution to achieving our ambitious climate change emissions reductions targets.

# <u>Proposals for a Heat in Buildings Bill: Consultation</u>

Like many other countries, Scotland has a legal target to reach 'net zero' greenhouse gas emissions. The way we heat our homes, workplaces and other buildings is the third-largest cause of greenhouse gas emissions in Scotland.

Scotland cannot meet our legal obligation to reach 'net zero' without changing the heating systems in the vast majority of our buildings.

The purpose of this consultation is to make you aware of proposals to make new laws around the heating systems that can be used in homes and places of work, and to invite your views on those proposals.

The Scottish Government plans to:

reconfirm that the use of polluting heating systems will be prohibited after 2045; and

- as a pathway to 2045, require those purchasing a home or business premises to end their use of polluting heating systems within a fixed period following completion of the sale
- introduce a new law that will require homeowners to make sure that their homes meet a reasonable minimum energy efficiency standard by 2033
- require private landlords to meet this minimum energy efficiency standard by 2028

The consultation describes proposals for how home owners and landlords can meet this standard – either through installing a number of simple insulation and draught-proofing measures, where those are possible, or by meeting a certain level of heat demand.

A new Leadership Practitioner Forum is being launched as part of the current Improvement Service and Solace Scotland transformation work, looking at proposals for a future operating model for councils and options for the future delivery of council services.

Members of the Leadership Practitioner Forum will attend a series of events that focus on <a href="the anchors and associated workstreams of the transformation programme">transformation programme</a>, bringing colleagues together to explore topics and challenges.

An investment scam is where you are convinced to move your money into a fictitious fund or pay for a fake investment which promised a high return.



People may be targeted by cold callers or presented with fake investment opportunities promoted on search engines and social media pressuring you to act quickly.

# **Argyll and Bute Council – Advice and Assistance in the Cost of Living Crisis**




The council and partners are working to support people and businesses affected by the cost of living crisis in Argyll and Bute.

Please find here a summary of that work, the sources of help and advice that are available and please feel free to share this with third parties and other organisations.

#### **DETAILS:**

Argyll and Bute's island, rural and mainland geography brings additional cost to our citizens' day to day lives (as highlighted in a report to Council on 29th September). For fuel costs alone this means that 70% of our households are at risk of fuel poverty or extreme fuel poverty; impact on additional key areas of living are outlined in the graphic below and at the end of this information note.



### Working with partners to support people and businesses:

The council's FIAG group (Financial Inclusion and Advice Group) brings together council services and support agencies. To make it as easy as possible for people to get support when they need it the council provides a 'one-stop-shop' of information on our website to provide key information and also help and information on money saving initiatives such as cheaper deals for internet connection and the availability of warm spaces provide by other organisations: <a href="https://www.argyll-bute.gov.uk/advice-services">www.argyll-bute.gov.uk/advice-services</a>

#### **Fuel**

#### Money

Bute Advice Centre and ALlenergy produced a booklet highlighting financial support services available across Argyll and Bute. This includes for example maximising income, foodbanks, energy and budgeting advice. It has been widely circulated to Elected members, across the NHS, Schools, support agencies and is available on the Bute Advice Centre website. Argyll and Bute Scotland Loves Local Gift Cards The Council is rolling out an initiative to provide £120 gift cards to around 6,650 Council Tax Reduction recipients. This will support households on low incomes and the local businesses registered for the card. The Council is looking at a proposal to develop Welfare Rights & Health Partnerships in Argyll & Bute. The pilot is looking at 5 practices within Mid-Argyll, Kintyre & Islay where the Council would embed Local Authority welfare advice specialists within the practice's healthcare setting

Data mining to identify benefits eligibility and maximise household income The Council's Data Advisory Group is working on matching data from relevant council systems to identify unmet benefit eligibility so we can support eligible households to maximize their income.

#### Food

<u>Flexible Food Fund</u>: The Fund provides a one-off cash payment to families on low incomes to help with food and fuel. The size of the payment is based on their household composition. Claimants are offered a second cash payment if they have engaged with support agencies, the Bute Advice Centre and ALIEnergy, in financial management. The project achieved national acclaim in October 2021 for Excellence in Innovation from the Institute of Revenue Rating and Valuation. Over 96% of people receiving the first grant payment engage, get the support they need and get a second payment; applicants, through different routes, have received a total of £2 million they could otherwise have missed out on.

Food banks: there is a list of food banks on the council's website

### Clothing

Preloved School Clothing Project. The Council and its schools are working with community groups to give every child in Argyll and Bute access to a school uniform, by developing a uniform re-use scheme. There is a reused school uniform hub in Helensburgh, one nearing completion in Campbeltown, and work in in planning for schemes for Dunoon, Rothesay, Oban and Lochgilphead, Tarbert, Islay and Mull. ### Support

Additional funding for advice agencies. The Council has provided £40,000 in funding to ALIenergy, Bute Advice Centre and the Argyll and Bute Citizens Advice Bureau to help them meet increasing demands from the public between 1 April 2022 to 31 March 2023. Anti-poverty training. The Poverty Alliance has delivered training across the Council and Community Planning Partners on anti-poverty actions and this will be extended to elected members on 30 November.

### **Promoting information**

The Council's Communications Team is already using social media and also statements provided to local press in the area to reach groups and individuals who perhaps don't use social media to make people who need it, aware of support available, using for example digital and traditional media channels, and word of mouth, inviting the help of Councillors, council employees, partner agencies and the public in passing information on, via whatever channels they have, to people who need it.

## **Grantnet – Funding Search Tool**

GRANTnet is a straightforward free to use service which can help you identify suitable funding for your activity or project across a wide range of funding sources.

#### What is GRANTnet?

- Up-to-date information on over 7,000 grants and other incentives,

- Data sourced from EC and UK Government sources, including Government departments, local authorities, charitable trusts and corporate sponsors.

#### **How to access GRANTnet**

You can access the Grantnet home page <u>here</u>.

When using the system for the first time, go to the 'Log in / Register' page here and enter your details including your e-mail address (this will become the username), name, organisation, postal address and telephone number. Clicking on the 'Register' button will generate an e-mail providing a password.

**Using GRANTnet -** When you log into the system you must answer some questions about your organisation and the project which you wish to undertake. GRANTnet will then provide an overview of all the funds available.
