### 1 Triennial Review of initial case reviews and significant case reviews (2018-2021) – Learning Event 1<sup>st</sup> July

The Care Inspectorate's Triennial review of initial case reviews and significant case reviews (2018-2021) will be published on 14 June. A learning event, facilitated by the Care Inspectorate and CELCIS will be held on the Learning Review Community of Practice (Knowledge Hub) on **1 July between 10am – 12pm**.

The session will provide an overview of the report and a short input on what works in supporting learning and practice change. This will be followed by three workshops which will explore key points for discussion.

### 2 Scottish Social Services Awards

Social Work Scotland has announced that the Scottish Social Services Awards, led by the Scottish Government and supported by Social Work Scotland and the Scottish Association of Social Workers (SASW), will take place after the Social Work Scotland conference on 26 October 2021. The deadline for nominations is 9 August, and finalists will be announced on 13 September.

### 3 Best Start Grant

The Scottish Government has announced that this year's Best Start Grant School Age Payment opened on Tuesday, 1 June, to families who get tax credits or certain other payments and have a child who was born between 1 March 2016 and 28 February 2017. Even if the child is not starting school, eligible parents and carers should still apply before the closing date on 28 February 2022. Best Start Foods payments are set to increase to £4.50 per week on 1 August to support low income families to buy healthy food for children under the age of three. To maximise the support available to families, income thresholds that apply to certain qualifying benefits are also set to increase.

### 5 National drugs mission funds: guidance

The Scottish Government has recently launched four funds to reduce drug related deaths and harms. These funds will be available for this year, and the next four years. Therefore, multi-year applications are welcome.

The funds are:

- Children and Families Fund: £3 million has been allocated to improve support for children, young people and families impacted by drug use, and ensure all children, young people and families have access to services
- Service Improvement Fund: £5 million has been allocated to continue the Improvement Fund, launched earlier this year. To provide improved services for outreach, treatment, rehabilitation and after care
- Local Support Fund: £5 million has been allocated to continue the Grassroots Fund, launched earlier this year. To provide access to funding for a wide range of communities and grassroots organisations which support the aims of the national mission
- Recovery Fund: £5 million has been allocated to support access to residential rehabilitation by providing additional residential rehabilitation capacity, support people to access residential rehabilitation and support people after they leave residential rehabilitation.

These funds are accessible to not-for-profit organisations working in the drugs sector, including Integration Authorities, Alcohol and Drug Partnerships, third sector organisations and grassroots/community organisations. <https://www.gov.scot/publications/national-drugs-mission-funds-guidance/>

## Research and Evidence Based Reports

### 15 Harmful Sexual Behaviours Online

Young Scot has recently published the final report of the Scottish Government-commissioned 'Harmful sexual behaviours online' survey, addressing one of the proposals of the Expert Group on Preventing Sexual Offending involving Children and Young People. The survey sought the views of young people on four issues:

- Personal safety online
- Education about sexual issues
- Reporting and support
- Effect of the coronavirus outbreak on online experience

### 16 Supporting and strengthening families through early help - A rapid review of evidence

In response to England's review of children's social care starting its work, the National Children's Bureau, with researchers from Cambridge University and the University of Kent, has published a scoping review exploring the academic and 'grey' literature to better understand the evidence base for the delivery and effectiveness of early help for families.

### 17 The National Confidential Forum Final Reports

The final reports from the National Confidential Forum have now been released. *Shining a Light on Care* explores the issues raised by the testimonies and sets out recommendations, and *My Message for Scotland*, is a collection of individual experiences, messages and reflections. The NCF has been running alongside the Independent Care Review and the ongoing Scottish Child Abuse Inquiry to offer a platform for people to speak anonymously and without cross-examination, taking care to try not to re-traumatise people who shared their stories.

## 18 Babies in care proceedings (England and Wales)

The Nuffield Family Justice Observatory has published a report providing new evidence about the number of newborn babies and infants in care proceedings in England and Wales, as well as the frequency of urgent hearings in these cases. Figures show that: in England, the number of newborn babies in care proceedings increased by 20% between 2012/13 and 2019/20, rising from 2,425 to 2,914 per year; in Wales, the number increased by 40 %, rising from 145 to 203 babies per year; London differs significantly from both Wales and many regions of England having the lowest numbers of newborn babies in care proceedings. <https://www.nuffieldfjo.org.uk/resource/newborn-babies-urgent-care-proceedings>

## 19 Health visitor enquiry about caregivers' adverse childhood experiences (ACEs)

Public Health Wales has published a report exploring key findings from the evaluation of a pilot intervention, which involved a supportive discussion about childhood adversity and its potential impact on individuals' health and wellbeing and that of their children, delivered with parents and caregivers during routine contacts with health visiting services. Findings from the pilot include: 95% of caregivers said that an enquiry about childhood adversity was acceptable in a health visiting context; and caregivers who had a discussion were significantly less likely to report experiencing parental stress (at six months post-partum), when compared with those who had not taken part in the pilot. <https://phw.nhs.wales/publications/publications1/health-visitor-enquiry-about-caregivers-adverse-childhood-experiences-aces-key-learning-from-a-pilot-evaluation/>

## 20 National Strategic Assessment (NSA) of serious and organised crime in the UK

The National Crime Agency (NCA) has published the 2021 National Strategic Assessment (NSA) of serious and organised crime in the UK. The assessment estimates there is between 550,000 and 850,000 people in the UK who pose varying forms of sexual risk to children. The NCA reports that collaboration with policing and other key partners has resulted in the safeguarding of nearly ten thousand children in the first nine months of 2020/21 and more than 7,000 arrests. <https://www.nationalcrimeagency.gov.uk/who-we-are/publications/533-national-strategic-assessment-of-serious-and-organised-crime-2021/file>

## 21 Children's helplines

Child Helpline International has published a report looking at the impact the coronavirus pandemic has had on the children and young people who contact child helplines around the world. Findings from quarterly surveys covering January to December 2020 include: globally, child helpline members received 25% more contacts in 2020 compared to 2019; violence and mental health were important reasons for contact globally; and requests for information about Covid-19, contacts relating to family relationships, access to essential services and the caller's own physical health were other main reasons for making contact.

### 23 In the Media

- The BBC has reported that the number of children and young people in Scotland waiting at least a year for mental health treatment has almost trebled since the start of the COVID-19 pandemic, and the Scottish Children's Services Coalition (SCSC) described the figures as the "worst on record"

- BBC News reports on findings from a survey of more than 1,500 UK teachers carried out by BBC Radio 4's File on 4 and NASUWT, the Teachers' Union looking at sexual abuse in schools. Findings include: almost a third of teachers surveyed said they had witnessed peer-on-peer sexual harassment or abuse; almost one in 10 said they saw it on a weekly basis; and more than half said they did not think adequate procedures were in place in their schools to deal with abuse. - Social workers and children’s charities in Wales are warning that a 20% decrease in child protection orders in Wales may be painting a false picture, fearing that many of the most vulnerable children are falling under the radar because of COVID-19 restrictions and that there may be an increase in referrals once restrictions ease
