

**THE ARGYLL AND BUTE COUNCIL  
(ROUTE A849, ISLE OF MULL)  
(BUNESSAN PRIMARY AND LOCHDONHEAD PRIMARY SCHOOLS)  
(PART-TIME 20 MPH SPEED LIMIT) (VARIATION) ORDER 202\_**

Argyll and Bute Council in exercise of the powers conferred on them by section 84(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them to do so, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, and having complied with Part II of the Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999, hereby make the following Order:

- 1 This Order May Be Cited As "The Argyll And Bute Council (Route A849, Isle Of Mull) (Bunessan Primary And Lochdonhead Primary Schools) (Part-Time 20 Mph Speed Limit) (Variation) Order 202\_" And Shall Come Into Operation On Monday The \_\_\_\_ Day Of \_\_\_\_ Two Thousand And \_\_\_\_.
- 2 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3 (1) No person shall drive any motor vehicle on the lengths of roads specified in the Schedule 1 to this Order at a speed exceeding 20mph when such speed limit applies to that length of road in accordance with paragraph (2) below.  
  
(2) A 20mph speed limit applies to the lengths of roads specified in the Schedule1 to this Order when a 20mph speed limit is indicated by a traffic sign displaying flashing amber lights.

## **SCHEDULE 1**

### **PART TIME 20 MPH SPEED LIMIT**

#### **Length of Road in Argyll and Bute**

##### **Buerness**

That length of the Salen-Craignure-Iona Ferry Road (Route A849) adjacent to Buerness Primary School, Buerness, Isle of Mull extending from a point 50 metres or thereby northwest of the extended northeast channel line of the Scoor Road (No.75) north westwards for a distance of 340 metres or thereby.

##### **Lochdonhead**

That length of the Salen-Craignure-Iona Ferry Road (Route A849) adjacent to Lochdonhead Primary School, Lochdonhead, Isle of Mull, extending from a point 22 metres or thereby southwest of the extended centreline of the Gorten Road (No 13) south-westerly to a point 20m southwest of the extended centre line of Swan Drive, for a distance of 465 metres or thereby.
