Whilst the overall emphasis in these proposals is very much focussed on adult services in Scotland, the consultation asks us to consider how Children's Services may work within these proposals. The debate and discussion will help inform the CPCScotland response.

## ANNOUNCEMENTS

### **National Hub for Reviewing and Learning from the Deaths of Children and Young People**

New arrangements for reviewing and learning from the deaths of children and young people came into force on **1 October 2021**. With the establishment of the National Hub, reviews should be conducted on the deaths of all live born children up to the date of their 18th birthday, or 26th birthday for care leavers who are in receipt of aftercare or continuing care at the time of their death.

These new arrangements, together with the recent introduction of national guidance for child protection committees undertaking learning reviews, will require some changes to the ways in which local authorities review the deaths of looked after children and young people experiencing care. The Care Inspectorate are currently updating their website to reflect these changes.

### **Disability Toolkit**

The Scottish Children's Reporter Administration and the Disabled Children Child Protection Network formed a research partnership to develop and pilot a Disability Toolkit which aims to:

- i. Identify additional needs that could have substantial and long-term impacts upon a child's ability to carry out normal day-to-day activities.
- ii. Provide an indicator of wider vulnerability and contextual factors that are pertinent to understanding child protection risk.

## **Guidance, Resources and Information**

### **The Foundations for Bairns Hoose (Scottish Barnahaus)**

In 2019, the Scottish Government commissioned Healthcare Improvement Scotland and the Care Inspectorate to jointly develop standards which will provide a blueprint for a Scottish Barnahaus (Bairns' Hoose). This work was paused in March 2020 due to the pandemic. In autumn 2020 to spring 2021, the project team undertook a comprehensive review of the first phase of the Barnahaus standards development. This report outlines the key learning from this review and aims to provide the Standards Development Group with information and guidance to resume this work.

This report shows the current state of poverty in Scotland, reporting that even before the COVID-19 pandemic Scotland has been blighted by poverty with a million people, including a quarter of a million children, trapped in poverty.

## **Understanding the mental health needs of women & girls experiencing gender-based violence**

Emerging evidence suggests that the COVID-19 pandemic, and the restrictions put in place to address it, has triggered a steep decline in women and girls' mental health and wellbeing, and increased the risk of experiencing gender-based violence. In response, the Improvement Service is coordinating a short-term research project which aims to ensure that the Scottish Government, COSLA, and other key partners have a robust understanding of:

- the mental health and wellbeing needs of women and girls who have experienced all forms of gender-based violence
- how these needs, and the systems and services in place locally to address them, have been impacted by the COVID-19 pandemic
- tangible actions for Scottish Government and/or councils as we move towards COVID-19 recovery and renewal.

New research into child maltreatment, led by the University of Glasgow, has found that children who have been maltreated are still at risk of developing mental health disorders up to 70 years after the abuse happened.

## **Supreme Court UNCRC Announcement**
