CAMPBELTOWN FLOOD PROTECTION SCHEME

The purpose of this letter is to keep you updated on the progress of the Campbeltown Flood Protection Scheme.

This is a £15million major engineering scheme which will put measures in place to reduce the impact of flooding on residents and businesses in Campbeltown.

Argyll and Bute Council has appointed DAWSON WAM to deliver this project.

We intend to commence construction within Burnside Square on 5th January 2023. These works will include:

- Installation of site hoarding and gates within the square
- Removal of trees and planters
- Excavation of the square to allow for tank installation
- Installation of attenuation tank
- Reinstatement of the square

To make sure these vital works can go ahead safely, temporary traffic management measures will be installed on Burnside Street and there will be parking restrictions on Burnside Street and within Burnside Square. Please see the attached layout of the site, which illustrates the works area required to complete the works.

The duration of the works is planned to be 6 months and upon completion, the square will be open for public use and parking.

The overall project will see new pipelines built under roads throughout the town to increase the capacity of the drainage system so that it can better cope with heavy rainfall.

Many of these new pipelines will lead into a storage tank which will be built underneath Burnside Square.

This tank will safely store water and allow it to slowly discharge. Burnside Square has been chosen for this because it is at a low point in the town and provides a clear open space to build the tank under. Once this element of the scheme is finished people will see no difference – the tank will be hidden underground.

We are aware the scheme will cause disruption and we apologise in advance, but these works are vital to ensure peoples' properties and businesses are not flooded in the way they have been in the past as a result of an out of date, undersized sewer system which is regularly overwhelmed.

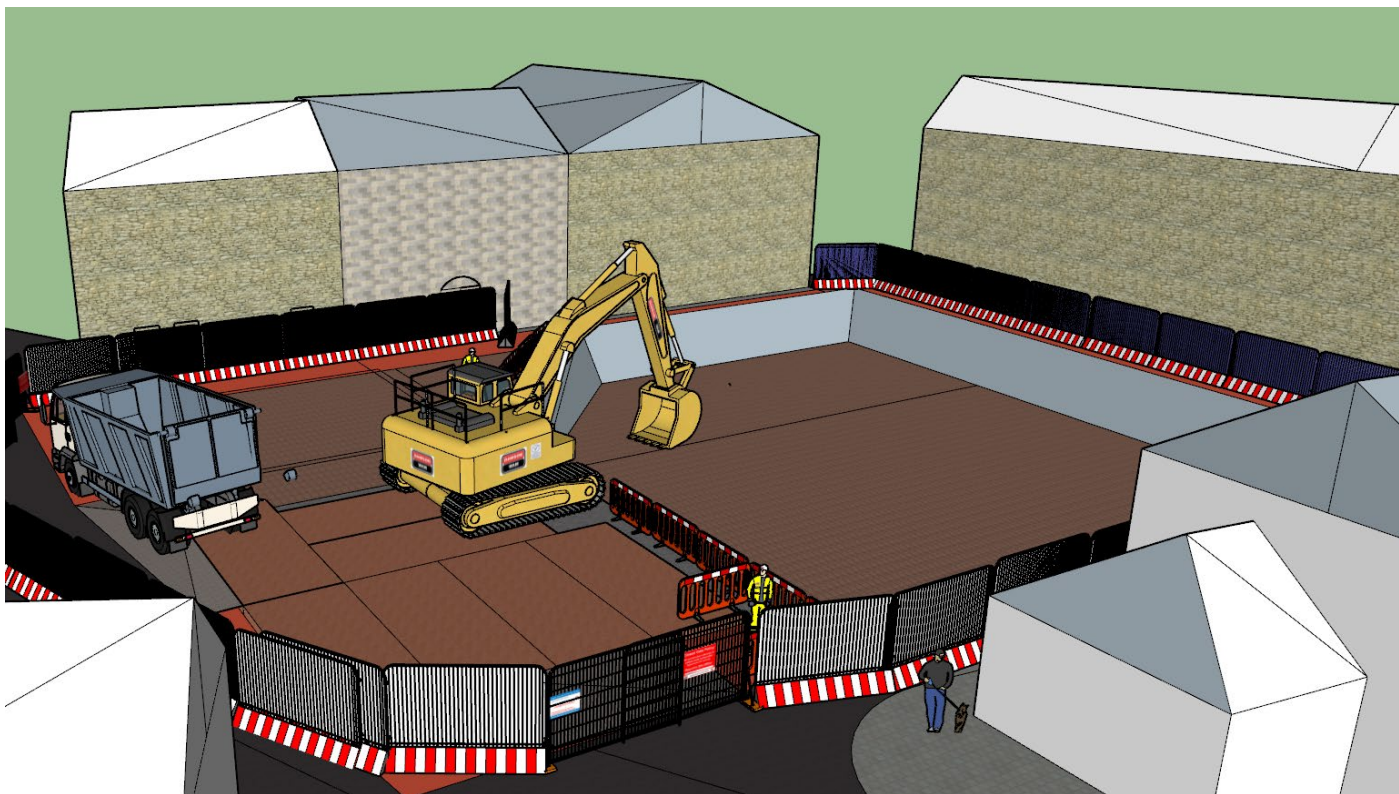

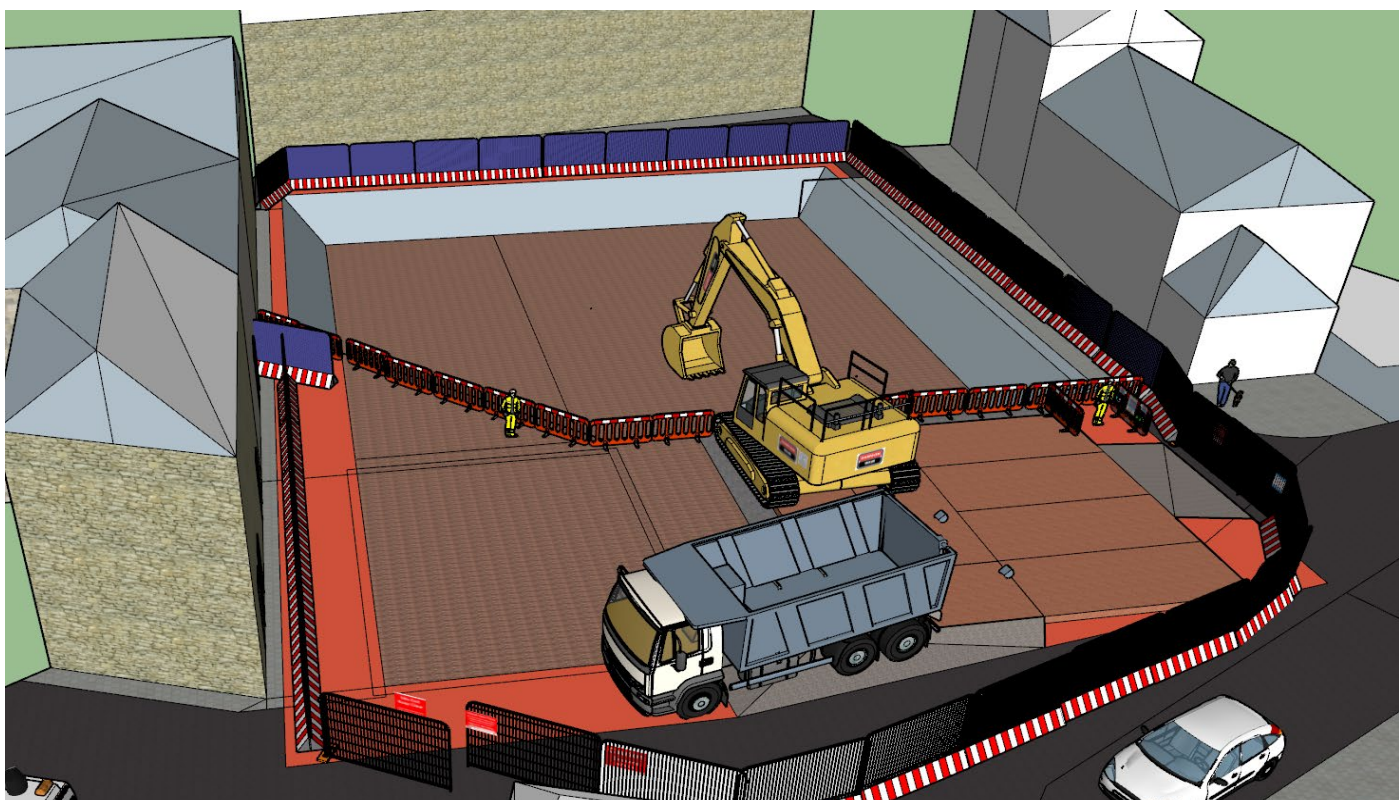
