## The Challenges Faced by Rural Landlords

Some of you may have participated in recent research funded by Argyll and Bute Council and Citizens Advice Scotland, and project managed by Argyll and Bute Citizens Advice Bureau (ABCAB), which aimed to better understand the challenges faced by rural landlords in Argyll and Bute.

The report set out recommendations for the Council, Citizens Advice Scotland, and the Scotlish Government, to help address the challenges faced by landlords and support the housing emergency by preserving the private rented sector.

Key recommendations for the Council have included the creation of regular newsletters, the provision of Landlord Forums, and the implementation of a Private Landlord Advice Hub on the Council website.

# **Home Energy Scotland**

Home Energy Scotland is the free, impartial advice service funded by the Scottish Government which can help landlords improve the energy efficiency of their rental properties. Whether you're looking to discuss your Energy Performance Certificate (EPC), various funding options or have your property assessed in depth, we can help.

The Highlands and Islands advice centre has specialists based in Argyll and Bute who will carry out assessments and provide you with a tailored reports outlining:



- · the current energy demands of your property
- · recommended improvements
- · the approximate cost of making these improvements
- potential fuel bill and carbon savings
- · the estimated improvement in the property's EPC rating.

Advice can be provided over the phone or following a visit to the property if appropriate. The property report also details potential funding options for each of the recommended measures in the report.

The Home Energy Scotland service is available to anyone who owns property in Scotland. A landlord can access the same advice and support for their own home, and they can encourage their tenants to get in touch for advice too.

# Leasing to the Argyll and Bute HSCP

Argyll & Bute Health and Social Care Partnership (HSCP) have a dedicated Empty Homes Officer who assists employees coming to work in the area to secure affordable housing.

The main aim of the project is to bring long-term unoccupied properties back into use and lease them to HSCP employees. However, this is not always practical due to the high demand for housing.



Landlords old or new are also encouraged to approach the service.

#### **DID YOU KNOW?**

Argyll and Bute Council is a stock-transfer housing authority, but from time-to-time still require to lease and manage properties to meet the temporary housing needs of people across Argyll and Bute. You can find out more about how you could lease your property to the Council on our website.

Leasing Spotlight on... The Repairing Standard

The Scottish Government announced updates to the Repairing Standard in 2023, which came into effect on 1st March 2024. These changes include:

Safe Kitchens – Private rented houses must have a safely accessible food storage and preparation space.

Fixed Heating Systems – Private rented houses must have a fixed heating system.

**Safe Access to Common Parts** – Tenants must be able to safely access and use any common parts of a tenement.

**Consent to Work On Common Parts** – A flat or tenement will not fail to meet the Repairing Standard if work cannot be carried out due to the majority of owners refusing consent to carry out the work.

Safe and Secure Common Doors - Common doors must be secure and fitted with satisfactory locks.

**Residual Current Devices** – Electricity supply installations must include a Residual Current Device, to reduce the risk of electrocution or fire.

**Lead Pipes** – Water supplies should be free of lead pipes from the boundary stopcock to the kitchen tap, or an appropriate water quality test carried out.

**Other Fuel Supplies** – The existing regulations around the supply of gas and electricity to private rented houses have been extended to include any other type of fuel.
