

NOTICE OF MAKING OF AN ORDER TO EXEMPT LAND FROM ACCESS RIGHTS

LAND REFORM (SCOTLAND) ACT 2003

Section 11 – Power to Exempt Particular Land from Access Rights

Application reference: **EX/26/01 - Dalmally Mart Park, Dalmally**

Notice is hereby given under section 11(9) of the Land Reform (Scotland) Act 2003 ("the Act") that on **Friday, 12 June 2026** Argyll and Bute Council made an Exemption Order ("the Order") under section 11(1) of the Act.

The effect of the Order is to exempt land at Dalmally Mart Park, Dalmally (marked in red on the accompanying map) from the access rights, which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. **This includes any parts of Core Paths or Public Rights of Way** recorded within the area.

The purposes for which the Order is made:

To charge a fee for entry and to prevent interference with the event

The Order will be in effect;

Saturday, 05 September 2026 - 06.00hrs to 19.00hrs

unless revoked earlier.

The Order is issued under the Land Reform (Scotland) Act 2003 and neither gives nor implies any other permission or consent that may be required.

This Notice should be displayed along with an accompanying map at each entrance point to the land in question for the entire duration of the exemption.

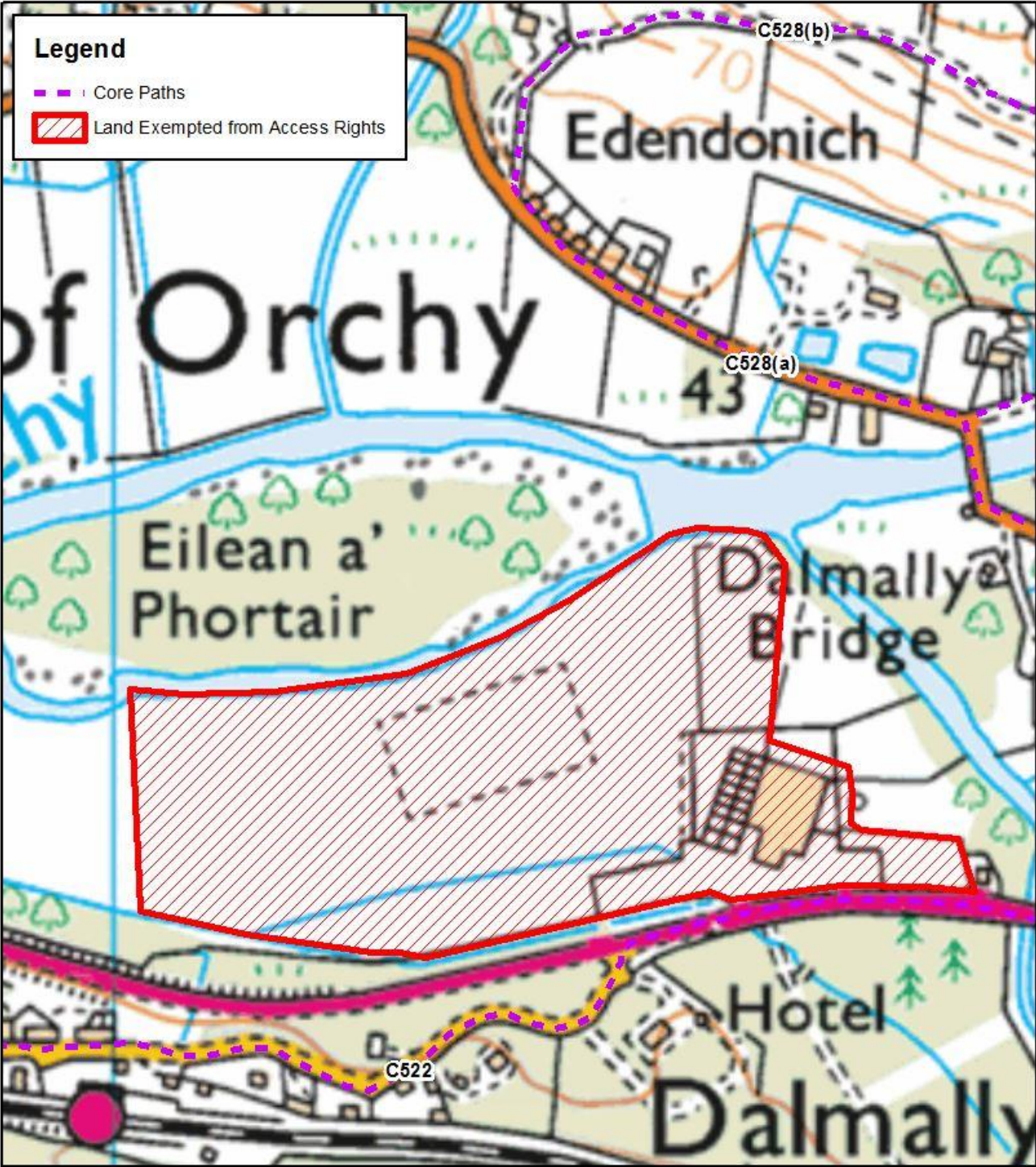
