Notice is hereby given under section 11(9) of the Land Reform (Scotland) Act 2003 ("the Act") that on **Friday, 12 June 2026** Argyll and Bute Council made an Exemption Order ("the Order") under section 11(1) of the Act.

The effect of the Order is to exempt land at Kintyre Show (marked in red on the accompanying map) from the access rights, which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. **This includes any parts of Core Paths or Public Rights of Way** recorded within the area.

The purposes for which the Order is made:

To charge a fee for entry, to prevent public interference with the event and to prevent the public from affecting the safety of the participants or spectators

The Order will be in effect;

Friday, 07 August 2026 - 0800hrs to 18.00hrs

unless revoked earlier.

The Order is issued under the Land Reform (Scotland) Act 2003 and neither gives nor implies any other permission or consent that may be required.

This Notice should be displayed along with an accompanying map at each entrance point to the land in question for the entire duration of the exemption.

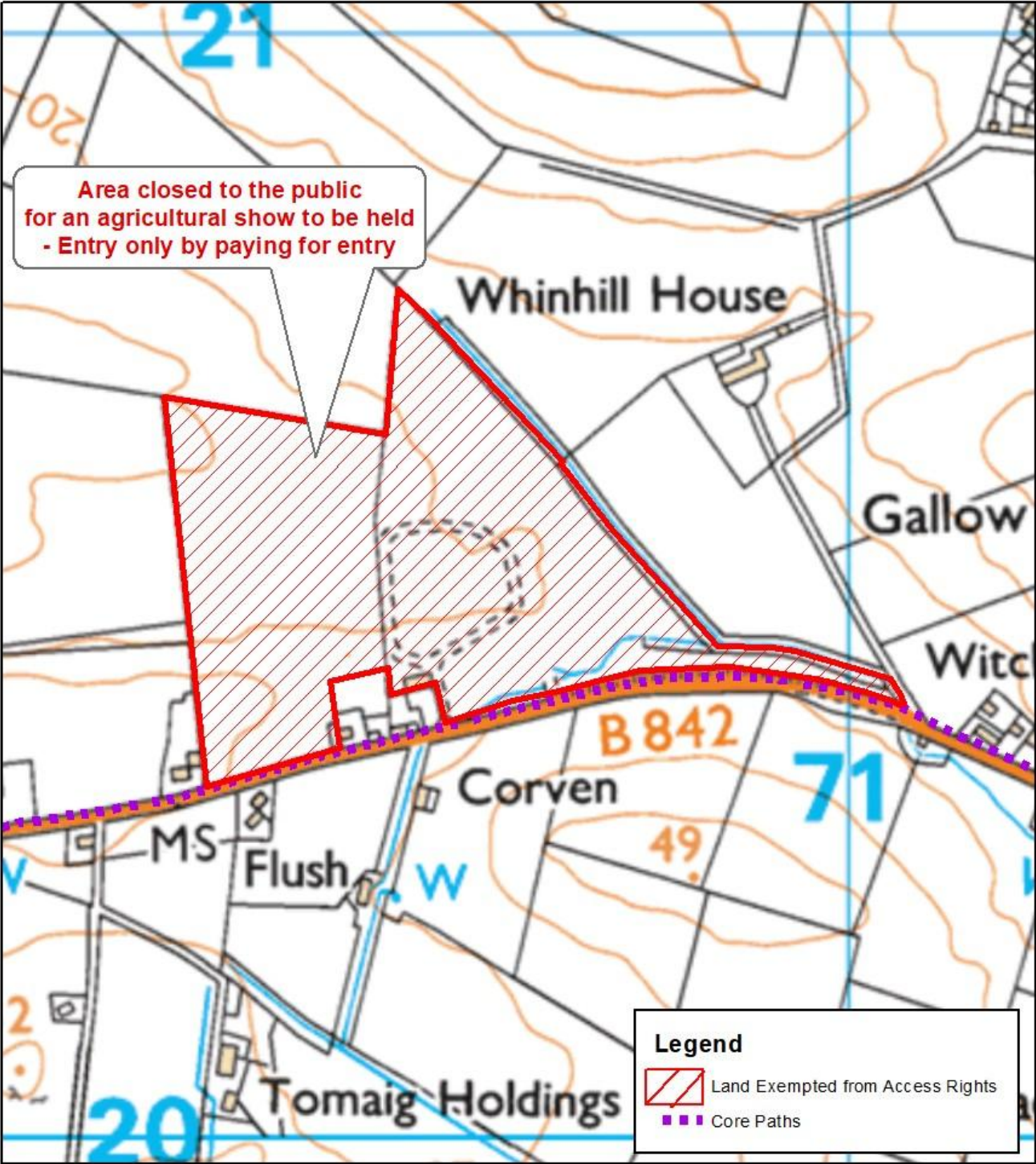
