## **ANNOUNCEMENTS**

### **1 Hidden Harm Among Scotland's Children and Families? Making Sense of COVID Data.**

This seminar from the University of Strathclyde will take place on 14<sup>th</sup> July between 12-1pm.

The weekly Vulnerable Children and Young People data submission from local authorities to Scottish Government has raised questions about a disconnect between higher levels of early stage child protection activity (e.g. increasing child protection concerns) and yet lower numbers of children becoming registered on the Child Protection Register or becoming looked after. Could this indicate instances of hidden harm where children and families' needs are not being fully assessed and then met?

In this session Alex McTier, Evidence and Evaluation Specialist at CELCIS will share research findings from interviews with 7 Scottish local authority areas and analysis of wider national data and evidence to help explain these divergent trends and what future priorities for action might be.

### **3 Forced marriage and FGM annual statistics**

The Home Office and the Foreign, Commonwealth & Development Office have published annual statistics on cases reported to the Forced Marriage Unit (FMU). Of the cases the FMU provided advice or support to in 2020, 15% involved victims who were aged 15 or under and 11% involved victims who were aged 16-17. These figures include cases related to forced genital mutilation (FGM), which often involves children.

### **5 Child neglect**

NSPCC Learning has published a statistics briefing on child neglect in the UK. It provides an overview of the data on neglect that is available and shares findings including: around 1 in 10 children in the UK have been neglected; concerns around neglect have been identified for half of children who are the subject of a child protection plan or register in the UK; and neglect was the most commonly mentioned form of abuse in contacts to the NSPCC helpline in 2020/21.

### **6 National drug and alcohol treatment waiting times**

This release by Public Health Scotland reports on the waiting times for people accessing drug and alcohol treatment services between 1 January to 31 March 2021. It contains information on the number of people seen for treatment, types of treatment accessed, and length of time waited.

## **7 Poverty and Inequality Commission Publications**

The Poverty and Inequality Commission has published their Child Poverty Scrutiny Report 2020-21 to the Scottish Government. The report states that unless very significant further action is taken now, the Scottish Government is going to miss the interim and final targets by a long way, leaving children and families locked into poverty. The Commission has also published their Annual Report, covering the period 1 April 2020 to 31 March 2021 and looks back at the work carried out during the past 12 months.

### **20 How coercive control harms child safety & wellbeing**

For 15 years, the Safe & Together Model has trained professionals in the importance of centering coercive controlling patterns of behaviors if you want to understand the harm domestic abuse perpetrators create for their children & how that is a parenting choice. Failures to link coercive control to child abuse & neglect make it easier to blame adult survivors, who are being protective, with failure-to-protect & parental alienation. New research is backing up this approach by exploring how coercive control impacts children directly via multiple pathways to harm. Dr Emma Katz, a leading research specialist in the harms caused by perpetrators to mothers and children in the context of domestic abuse will discuss this research.

## **21 Children's Health in Care in Scotland (CHiCS): Initial findings from linked administrative data research and Knowledge Café**

## **Research and Evidence Based Reports**

### **22 COVID Learning Report: Supporting Children's Wellbeing During COVID-19**

Inspiring Children's Futures at the University of Strathclyde has released the first in its series of Learning Reports from the COVID 4P Log Project, which, using responses from 22 countries, provides findings about successes in supporting children's wellbeing during the COVID-19 pandemic; challenges to service provision and their impact on children and families; and lessons learned and recommended actions for improving outcomes for children.

### **23 How Families with Young Children Experienced Lockdown**

The findings of new landmark research by the charity Save the Children has revealed that families on low incomes struggling to survive before lockdown have been tipped into crisis by the pandemic - it warns that young people living in poverty must be a priority for the Scottish Government's post-Covid recovery plans.

### **24 Inequalities in Child Development**

Public Health England has published experimental statistics on inequalities in child development in England. The statistics provide data on the characteristics of children aged 2- and 3-years-old who have had their development assessed using the Ages and stages questionnaire (ASQ-3). Characteristics include: sex; ethnicity; looked-after children; disability; vulnerability; and children with a child protection plan.

## **25 Young, caring and struggling to make ends meet - The worsening economic circumstances of Scotland's young carers during Covid-19**

This report from Too many young carers in Scotland are facing deepening money pressures and increasingly unable to make ends meet, according to a University of the West of Scotland and Oxfam report. The charity says it is 'deeply concerned' about 'escalating daily pressures'.

## **26 Inequality and social care**

Findings from research by Kingston University and Ofsted into the relationship between deprivation and social care intervention in England include: children from the poorest neighbourhoods were almost 14 times more likely to be referred to social care services than those from the richest areas; the shift in balance in children's social care provision from early to late intervention over the last decade has exacerbated this divide; and disparities were driven by a rising identification of neglect, which coincided with increased poverty and inequality.
