## 1 CELCIS announce online conversation

## **Research and Evidence Based Reports**

### **18** Safeguarding Approaches in Child Sexual Abuse

The Centre of expertise on child sexual abuse (CSA Centre) has published a report looking at how child sexual abuse is identified and responded to within complex safeguarding approaches. Findings from telephone interviews, an online focus group and an online survey of 64 practitioners highlighted the complexities in language used to distinguish child sexual abuse and child sexual exploitation and the challenges professionals face in addressing concerns of child sexual abuse, especially without verbal disclosure. ## 19 Child Poverty Research

The Centre for Research in Social Policy at Loughborough University has published research estimating the cost of child poverty in the UK which and found that the cost of dealing with child poverty has risen by £8 billion since 2013. The study looked at the level of child poverty, earnings and benefits spending on services due to child poverty and policies that direct public spending towards children in low-income families:

## **21 TACT call for National Care Family service to be established**

UK fostering charity TACT has published a paper calling for a national care service, or 'National Care Family (NCF)', a lifelong service covering fostering, adoption, kinship, and residential care (or foster based group care) and secure care, as well as supporting birth parents whose children return to them from care – the charity proposes that local authorities would no longer hold parental or operational responsibility for children in 'public' care.
