

**ARGYLL AND BUTE COUNCIL
(CRINAN CANAL TOWPATH ROAD, CAIRNBAAN)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019**

Argyll and Bute Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, (as substituted by the Road Traffic (Temporary Restrictions) Act 1991), and having complied with the Road Traffic (Temporary Restrictions) Procedure Regulations 1992, hereby make the following Order:

Citation and Commencement

1. This Order may be cited as the “Argyll and Bute Council (Crinan Canal Towpath Road, Cairnbaan) (Temporary Prohibition of Traffic) Order 2019” and will be effective, when indicated by signs, from 0001 hours on Monday 2nd September to 2359 hours on Sunday 29th September 2019, or until the works are complete, whichever is the earlier.

Interpretation

2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition of traffic

3. No person shall drive or cause or permit to be driven any motor vehicle on the length of road as specified in Schedule 1 to this order.

Prohibition of Waiting

4. No person shall cause or permit any vehicle to wait at any time on the length of road specified in Schedule 2 of this Order.

Exemptions

5. No prohibition imposed by this Order applies to a vehicle:-
 - (a) being used for carrying out the works;
 - (b) being used in an emergency for fire brigade, ambulance, police or coastguard purposes;
 - (c) accessing an affected property.

PROHIBITION OF TRAFFIC

<u>Name of Road</u>	<u>Extent of Closure</u>
Crinan Canal Towpath Road, Cairnbaan	From the east end of Lock 7 extending in an easterly direction for a distance of 110 metres or thereby.

<u>Name of Road</u>	<u>Extent of Waiting Restrictions</u>
Crinan Canal Towpath Road, Cairnbaan	That section of layby situated on the north side of the road, 100 metres or thereby east of Lock 7.
